And take notice, that in default of your so doing, the plaintiff may proceed therein, and judgment may be given in your absence.— Witness the Right Honourable Hugh MacCalmont, Baron Cairns, Lord High Chancellor of Great Britain, at Westminster, the fourth day of February, in the year of our Lord one thousand eight hundred and seventy-six.
